 - Concrete Deck Lifting – This is separating the coping from the pool allowing water to penetrate behind wall.
 - Concrete Deck Sinking – This has caused one skimmer to become crushed and potentially a surface crack in the wall has begun.

- Concrete Deck Sealing – Topcoat needs cracks caulked and/or surface coating.
- Concrete Coping Repair – Chunks of concrete are becoming dislodged and needs to be rubbed out. Additionally, new expansion joint needs to be installed between coping and pool tiles.
